

# MEMBERSHIP CONTRACT this Date

apply for membership to Healing Salts, LLC, a private spa health facility. With the signing of this membership agreement I/we accept the offer made to become a member of Healing Salts, LLC dba
Healing Salt Spa halotherapy services as outlined below, and have read and agree with the following.
General rules:
The monthly payment of \$ will be debited from the credit card authorized by you. You
agree to sign all documents necessary to ensure that the monthly payments can be made by direct debit.
The length of the Initial Term (MONTHLY) has been discussed with you and you agree that the
monthly options for direct debit are payable on a monthly basis until canceled by client and during any
Continuing Membership Period even if you do not use the facilities provided by Healing Salts, LLC
dba Healing Salt Spa. It is your responsibility to ensure sufficient funds are in the nominated account
when the regular payments are to be drawn and if a debit is unsuccessful you will be responsible for
any administration fees and/or collection fees. We may, in our absolute discretion, deny entrance into
our salt spa until your account is up to date should the prior debits be unsuccessfully processed.
If the authorized bank account/credit card is canceled/closed or a payment amount disputed, a charge of
\$25.00 may apply and any overdue monthly payment will immediately become payable.
Membership fees are payable whether or not you have utilized Healing Salts, LLC dba Healing Salt
Spa halotherapy services. You are given a monthly allowance of 1 salt session per month. Each unused
month gets rolled over to the next month. The membership fees are non-refundable, is not transferable
to another person, a picture ID could be required. Booking depends on availability. Membership
includes Adult Salt Therapy sessions only in the Salt Room or Salt Bed.

## Your Right to Cancel:

You may cancel this Agreement for any reason by giving 30 days written notice emailed to <u>HealingSaltSpa@gmail.com</u>.

### Ongoing Agreement:

This is an ongoing membership agreement. The agreement will continue until either you or Healing Salts, LLC dba Healing Salt Spa terminates it in the way described in the agreement. If an automatic debit arrangement is in place, membership fees will continue to be debited from your credit card until you or Healing Salts, LLC dba Healing Salt Spa cancels the arrangement via email. If you terminate the agreement or stop the automatic debit arrangement in a manner not described in the agreement, then you may be liable to Healing Salts, LLC dba Healing Salt Spa for damages for breach of contract in the amount of \$60.

#### Late Fees:

You agree to pay a \$25.00 late fee if your monthly payment is received past the due date and/or any fee associated with returned payments or non-payment of dues. Should you default, you agree to pay all collection costs including agency fees or administration charges, court or arbitration costs and reasonable attorney fees, which may be paid or incurred by Healing Salts, LLC dba Healing Salt Spa. You agree that Healing Salts, LLC dba Healing Salt Spa or a third party, and their agents and assigns may send communications to you including late payment notifications and other related

correspondence.

#### Assignment:

You have no right to assign or otherwise transfer your rights under this Agreement to any other person.

# Maintenance of Facilities:

Healing Salts, LLC dba Healing Salt Spa may be temporarily closed for periods of up to 2 weeks each year for maintenance purposes. If a facility maintenance schedule is needed in the future, you will be given a minimum of a 30 days' notice to use your membership for said month without any adjustments to be made to membership.

## Appointments:

Member is required to give Healing Salts, LLC dba Healing Salt Spa 24 hours notice for any appointment which can't be kept. Member will be charged \$10 fee for every no show/no call or last minute cancellation. Healing Salts, LLC dba Healing Salt Spa reserve the rights to reschedule any appointment made for more than one session a day.

Included in Membership: \$30 per month or \$175 unlimited monthly sessions

1x per month Adult Salt Therapy sessions (unused sessions roll over to the following month)
